4. Events Leading to Appointment of Liquidators

The Director of the company has advised the reason for the failure of the Company is due to delays caused by Regulatory Authorities in the completion of contracts along with lack of profitability.

In October 2017 Worksafe New Zealand issued a number of enforcement notices on various sites which resulted in the Company ceasing to trade.

In conjunction with the regulatory issues, in 2016 a former company director/shareholder was bought out by the company. This buyout had a negative impact on the company cash flow and profitability.

Prior to Liquidation, management completed a review of all outstanding contracts and established many would result in a negative return if completed.

After the Company ceased to trade a number of contracts were terminated by clients. The balance have since been disclaimed by the liquidators.

5. Statement of Affairs

We attach as *Appendix I* a statement of the Company's affairs as at the date of our appointment.

This has been prepared from information provided by a director of the Company and the Liquidator is not yet able to express an opinion on the validity of that information.

Also attached as **Appendix II** is a list of known creditors as at the date of appointment.

6. Proposals for Conducting the Liquidation

The Liquidator will review the Company's books and records to establish if there are any potentially voidable transactions, any potential shareholder current issues and ensure the Director/s have complied with their duties and obligations imposed on them under the Companies Act 1993.

In particular the Liquidator will be looking at related party transactions. We note some assets were transferred out of this company after it ceased to trade. We also note that the General Security agreement holder (the Company's banker) had its debt fully repaid by a related company prior to liquidation.

7. Estimated Date of Completion of Liquidation and Notice As To Further Reports

It is not practicable to estimate the date of the completion of the liquidation at this stage. Further reports will be issued six monthly, with a final report at the conclusion of the liquidation.

8. Creditors Meeting

Having regard to the assets and liabilities of the company, the likely result of the liquidation and other relevant matters, the Liquidator considers in accordance with section 245 of the Companies Act 1993 that no such meeting should be held.

A meeting will not be called unless within 10 working days after receiving this notice a creditor gives notice in writing to the Liquidators requiring a meeting to be called.

The Liquidator dispenses with holding a creditors meeting pursuant to Section 243 of the Companies Act 1993 as the dividend is expected to be nil or very small.

- c) the costs of calling the meeting would be out of proportion to the value of the company's assets.
