Receiver's First Report on the State of Affairs of Landgro Limited, Britomart Trustee Company Limited, Boiler Gully Forest Investments Limited, Stephen Robert Kelly, Stephen Robert Kelly as Trustee for the 44 Kempthorne Trust and Stephen Robert Kelly as Trustee of Kelly Family Property Trust (All in Receivership) 'the Companies and Individual' as at 6 May 2019

Opening

Thomas Lee Rodewald was appointed as Receiver of the above-named Companies and Individual on 6th March 2019 under the powers contained in a general security agreement dated 20 September 2017 which property consists of all present and after acquired property.

We set out below our first report on the state of the affairs of the above named company as required by section 23 of the Receivership Act 1993.

Landgro Limited is the principle borrower of the loan and the remaining parties that are in receivership are guarantors of the principle borrower.

Events leading up to our Appointment

In the days leading up to the appointment, the Receiver was approached by Asset Finance Limited. Discussions were held with the appointer, the result being, due to a default in the general security agreement, the decision was made to appoint a receiver and manager as soon as possible.

Nature of Business

Landgro Limited traded as a property developer and held an undeveloped property located at 6 Huka Road, Birkenhead, Auckland. The company had engaged various contractors to provide services in preparation for obtaining a resource consent for the property. However, at the time of appointment no resource consent application had been lodged.

We have yet to fully establish the trading activities of the other entities/guarantors.

Debtors

The Receiver has not identified any debtors in the company. Given the nature of the business we are not expecting that there are any debtors to collect.

At the date of the Receiver's appointment the amounts owing were as follows:
