Schwarzerhund Limited ("the Company") was placed into liquidation by Order of the High Court at Rotorua on the 19th day of May 2020. Thomas Lee Rodewald, Licenced Insolvency Practitioner of Tauranga was appointed as Liquidator of the company.

We set out below our six-monthly report on the state of affairs of the above-named company as required by section 255 (2)(d) of the Companies Act 1993.

Prior to liquidation the petitioning creditor obtained an injunction in regard intellectual property and trademarks issues. The Liquidator received independent legal advice and reached a settlement over the matter which was approved by the company director.

Company assets were sold under control of Grant Johns our external Asset Manager.

The debtors ledger was reviewed and minor recoveries made.

4. Estimated Date of Completion of Liquidation and Notice As To Further Reports

The liquidation will be completed early next year. High Court approval of fees charged will be required. It is anticipated that a small dividend will be paid to unsecured creditors.
