Thomas Lee Rodewald, Licenced Insolvency Practitioner was appointed as Receiver of the abovenamed Companies, Trusts and Individual on the 6<sup>th</sup> day of March 2019 under the powers contained in a general security agreement dated 20<sup>th</sup> September 2017 which property consists of all present and after acquired property.

We set out below our final report on the state of the affairs of the above-named Companies and Individual as required by section 29 of the Receivership Act 1993.

Landgro Limited is the principal borrower of the loan and the remaining parties that are in receivership are guarantors of the principle borrower.

On the 13<sup>th</sup> day of January 2021, the Receiver of Britomart Trustee Company Limited appointed David Thomas, a Licenced Insolvency Practitioner of Tauranga as Liquidator of Landgro Limited (In Receivership)

The property owned by Landgro Limited was sold to a third party by private treaty after efforts to sell via a real estate agent were unsuccessful. No realisations were achieved via the receivership of the guarantors.

## **Payments to Secured Creditors**

The amount of \$2,725,936.53 was paid to the General Security Holder/mortgage holder, being Asset Finance Limited. A substantial sum remains outstanding relating to interest and other costs.

## **Ceasing to Act**

The Receivers and Managers ceased to act on 13 January 2020.

Control of the Landgro Limited has reverted to the Liquidator, whilst the remaining companies have reverted to the director.
