Thomas Lee Rodewald, along with Kenneth Peter Brown, Licensed Insolvency Practitioners were appointed as Receivers of the above-named company on 1 December 2021. On the same date the same Receivers were appointed to the guarantor of the company secured debt Xiaoguang (Terry) Song.

The Receivers were appointed pursuant to the powers contained in an Account Application Form dated 10 July 2017 and three Finance Agreements all dated 5 May 2020 in favour of Porter Finance Limited pursuant to section 6(2) of the Receivership Act 1993 ("**the Act**"). The appointment was in respect of all of the Company and Individual's present and future rights in any land and any other property or asset, other than any personal property to which Personal Property Securities Register Act 1999 applies. property.

The Receiver can confirm that they have validated both the security due to the appointer and their appointment.

We set out below our final report on the state of the affairs of the above named company as required by section 24 and 24a of the Receivership Act 1993.
