Appointment

Thomas Lee Rodewald, a Licensed Insolvency Practitioner was appointed as Receiver and Manager ("**Receiver**") of the above-named Company on 19 July 2024 at 3.30pm.

The Receiver was appointed pursuant to the powers contained in a General Security Agreement ("**GSA**") in favour of the Bank of New Zealand ("**the GSA Holder**") dated 9 December 2016, pursuant to section 6(2) of the Receivership Act 1993 ("**the Act**"). The appointment was in respect of all of the Company's present and after acquired property and all personal property in which the Company has rights, whether now or in the future.

The Receiver can confirm that he has validated both the security due to the appointer and his appointment.

We understand the Company may have been placed into liquidation following a Court application heard on 10 September 2024, but to date we note the Official Assignee has not filed an appointment notice with the Companies Office.

Commentary

The Company traded from the Director's address and was a forestry contracting business having traded since 2006. The Receiver was approached by the GSA Holder to act as Receiver of the Company due to defaults under the securities. The Director has advised that the reason for the failure of the Company which led to the appointment of the Receiver, was due to difficult trading conditions, a dispute with a major creditor, slow payment by a large debtor and the cancellation of a sale agreement with a buyer of some major plant and equipment items.

Following appointment the Receiver established there were numerous assets plant and equipment assets, most of which were secured to various parties, and in various locations.

Statement of the Company's Affairs

A statement of the Company's estimated financial position as at the date of Receivership is provided in **Appendix One.** This statement has been prepared based on information obtained from the Company, its officers and creditors. The information has yet to be verified for validity and may be subject to change.

Proposals for Conducting the Receivership

The Receiver will take steps to realize the available assets of the Company with a view of making a distribution to the GSA Holder. The Receiver will review secured creditor documentation and then liaise with the secured creditors to establish what their intentions are regarding their secured assets.

The Receiver will also terminate the employee contracts and endeavour to settle preferential employee entitlements.

While the Receiver is not responsible for the administration of unsecured creditors' claims, it is noted that unsecured creditors may not receive a distribution if recoveries do not permit. At the conclusion of the receivership, the Receiver will distribute any available funds to the Director, or a Liquidator if one has been appointed.

Assets

The Receiver have been advised that the Company had the following assets as at the date of the Receivership:

- Bank balance
- Accounts receivable
- Forestry plant and equipment
- Motor vehicles
- Office furniture and fittings
- Shareholder current accounts

It is too early to determine the realizable value of these assets and/or any potential claims available to the Receiver. The Receiver is also investigating whether there are any other assets and/or potential claims which may give rise to additional recoveries for the benefit of creditors.

Creditor Claims

In accordance with section 23(1) of the Act, a schedule of all known creditors of the Company as at the date of this report is provided in *Appendix Two*.

Secured Creditor Claims

The GSA Holder registered a financing statement on the Personal Properties Securities Register ("**PPSR**") in respect of all of the Company's present and after acquired property. A total of \$702,922 was owed to them as at the date of the Receivership. No distribution has been made to the GSA Holder, to date.

We note Porters Finance Limited have a first charge registered ahead of the GSA Holder, and so they have priority for any realization on assets.

Our search of the PPSR shows 13 parties had registered financing statements against the Company. The registrations are summarized at *Appendix Three*.

To date the Receiver has received secured claims of \$1,587,684 from 9 PPSR secured creditors. No distribution has been made to secured creditors, although Porters Finance Limited took position of assets subject to their specific securities.

Preferential Creditor Claims

The Receiver was advised there were 13 employees and there were employees preferential claims for wages and holiday pay. The Receiver has paid the wages claims and the majority of the holiday pay claims, to date.

We have yet to receive a claim from the Inland Revenue Department but the Summary my-IR indicates outstanding GST of \$11,424 and Paye of \$115,764. No distribution has yet been made to the Inland Revenue Department.

Unsecured Creditor Claims

To date the Receiver has received 10 claims from unsecured creditors. These total \$83,232. No distribution has been made to unsecured creditors.

Estimated Completion Date

It is not practicable to estimate the date of completion of the Receivership or if there will be any distribution at this stage. However, if you are an interested party and wish to assist the Receiver by providing additional information that would assist the Receivership, please contact the Receiver as soon as possible. The Receiver requests that the information be provided in writing along with copies of supporting documentation.

Statutory Reporting

Further reports will be issued within 2 months after every 6 months, following the date of appointment, and a final report will be issued at the conclusion of the Receivership, pursuant to section 24 of the Act.
